

## MOBILE APPLICATION TERMS OF USE

These Mobile Application Terms of Use ("Terms") govern your use of any mobile application downloaded or otherwise acquired by you ("App") that is made available by Viewpoint, Inc. or its affiliated companies and subsidiaries ("Viewpoint"). By using the App, you accept and agree to these Terms. If you do not agree to these Terms, do not use the App. Viewpoint reserves the right to modify these Terms from time to time by posting updated Terms. Your continued use of the App following the posting of such modifications will mean that you accept and agree to the modified Terms. If you are dissatisfied with any modifications to these Terms, your exclusive remedy is to discontinue use of the App.

In the event that you are accessing and using the App as an authorized user under a separate license or subscription agreement for a Viewpoint product that is used in conjunction with the App ("User"), then that separate agreement supersedes these Terms and shall govern your access and use of the App.

### LICENSE

Viewpoint grants you a limited, worldwide, nontransferable, nonexclusive license to install the App on any mobile device that you own or control in accordance with these Terms. The App is licensed, not sold, to you. You may not rent, lease, lend, sell, redistribute, or sublicense the App. You may not copy, decompile, reverse engineer, disassemble, attempt to derive the source code of, modify, or create derivative works of the App, any updates, or any part thereof (except as and only to the extent any foregoing restriction is prohibited by applicable law or to the extent as may be permitted by the licensing terms governing use of any open sourced components included with the App). Any attempt to do so is a violation of the rights of Viewpoint and its licensors. The terms of this license will govern any upgrades provided by Viewpoint that replace and/or supplement the original App, unless an upgrade is accompanied by a separate license in which case the terms of that license will govern. If documentation is provided with the App, you may copy and use the documentation for reference purposes in connection with your use of the App.

### PROPRIETARY RIGHTS

As between you and Viewpoint, Viewpoint and its licensors retain all ownership rights in and to all text, graphics, interfaces, photographs, documentation, trademarks, service marks, logos, artwork, software, code, and other content in the App, excluding User Content, as defined below (collectively, "App Content"), and all intellectual property rights incorporated into or related to the App Content. You acknowledge that the goodwill associated with trademarks and service marks of Viewpoint belongs exclusively to Viewpoint. All rights in the App Content not expressly licensed by Viewpoint under this Agreement are reserved.

### USE OF YOUR PERSONAL INFORMATION

You agree that Viewpoint may collect and use personal information about you in connection with your use of the App. The use of your personal information is governed by Viewpoint's Mobile Application Privacy Policy, which is incorporated into and made a part of these Terms. You agree that any personal information you provide or make available to Viewpoint is accurate and truthful to the best of your knowledge and you agree to update your information as necessary to maintain its accuracy and truthfulness.

### ACCESS LEVELS

To use certain features of the App, you must be a User under an active license or subscription for a Viewpoint product that is used in conjunction with the App ("Platform"). Users will use the same login credentials to access the App that they use to access the Platform. Users are responsible for maintaining the confidentiality and security of their username and password. Users are responsible for all activity that occurs under their username and password and agree to immediately notify Viewpoint of any unauthorized use of their username or password.

If you are not a User, you will have access to limited features of the App for demonstration purposes only. Non-Users will not be issued and may not create login credentials. Non-Users may not upload User Content to the App.

#### SUPPORT

Viewpoint is not responsible for providing support or maintenance services to non-Users in connection with their use of the App.

#### NO UNLAWFUL OR PROHIBITED USE

As a condition of your use of the App, you represent and warrant to Viewpoint that you will not use the App for any purpose that is unlawful or prohibited by these Terms. You may not use the App in any manner that could damage, disable, overburden, or impair the App or servers or networks connected to the App. You agree that your use of the App will not violate the rights of any third party or breach any contract or duty to any third party. Viewpoint reserves the right, but has no obligation, to investigate your use of the App to determine whether you have violated these Terms or failed to comply with any applicable law.

#### FEEDBACK

If you provide any ideas, suggestions, or other feedback to Viewpoint related to the App ("Feedback"), you acknowledge and agree that the feedback will be non-confidential and Viewpoint will be free to use the Feedback for any purpose without compensation to you.

#### TERMINATION

These Terms and the license to the App are effective until terminated by you or Viewpoint. You may terminate these Terms and the App license at any time by ceasing use of the App and destroying all copies of the App in your possession or under your control. Viewpoint reserves the right to modify or terminate the App or your access to the App for any reason, without notice, at any time, and without liability to you. Upon termination, all licenses and other rights granted to you in these Terms will immediately cease.

#### NO WARRANTY

YOU EXPRESSLY ACKNOWLEDGE AND AGREE THAT USE OF THE APP IS AT YOUR SOLE RISK AND THAT THE ENTIRE RISK AS TO SATISFACTORY QUALITY, PERFORMANCE, ACCURACY, AND EFFORT IS WITH YOU. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, THE APP AND ANY SERVICES PERFORMED OR PROVIDED RELATED TO THE APP ("SERVICES") ARE PROVIDED "AS IS" AND "AS AVAILABLE," WITH ALL FAULTS AND WITHOUT WARRANTY OF ANY KIND, AND VIEWPOINT HEREBY DISCLAIMS ALL WARRANTIES AND CONDITIONS WITH RESPECT TO THE APP AND ANY SERVICES, EITHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES AND/OR CONDITIONS OF MERCHANTABILITY, OF SATISFACTORY QUALITY, OF FITNESS FOR A PARTICULAR PURPOSE, OF ACCURACY, OF QUIET ENJOYMENT, AND NON-INFRINGEMENT OF THIRD PARTY RIGHTS. VIEWPOINT DOES NOT WARRANT THAT THE OPERATION OF THE APP OR SERVICES WILL BE UNINTERRUPTED OR ERROR-FREE, OR THAT DEFECTS IN THE APP OR SERVICES WILL BE CORRECTED. NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY VIEWPOINT OR ITS AUTHORIZED REPRESENTATIVE SHALL CREATE A WARRANTY. EXCEPT AS OTHERWISE EXPRESSLY PROVIDED HEREIN, SHOULD THE APP OR SERVICES PROVE DEFECTIVE, YOU ASSUME THE ENTIRE COST OF ALL NECESSARY SERVICING, REPAIR, OR CORRECTION. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES OR LIMITATIONS ON APPLICABLE STATUTORY RIGHTS OF A CONSUMER, SO THE ABOVE EXCLUSION AND LIMITATIONS MAY NOT APPLY TO YOU.

#### LIMITATION OF LIABILITY

VIEWPOINT'S CUMULATIVE LIABILITY TO YOU FOR ALL CLAIMS IN ANY WAY ARISING OUT OF OR RELATING TO THESE TERMS, THE APP, AND ANY SERVICES, REGARDLESS OF THE FORM OR THEORY OF ACTION (INCLUDING BREACH OF CONTRACT, STRICT LIABILITY, TORT (INCLUDING NEGLIGENCE) OR ANY OTHER LEGAL OR EQUITABLE THEORY), SHALL NOT EXCEED FIFTY DOLLARS (\$50.00). IN NO EVENT WILL VIEWPOINT HAVE ANY OBLIGATION OR

LIABILITY FOR INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL, EXEMPLARY, PUNITIVE, OR AGGRAVATED DAMAGES, LOSS OF GOODWILL, LOSS OF DATA, OR ANTICIPATED PROFITS ARISING FROM OR RELATING TO THIS AGREEMENT, YOUR USE OF OR THE PERFORMANCE OF THE APP OR ANY SERVICES PROVIDED, OR FOR ANY OTHER REASON, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH POTENTIAL LOSS OR DAMAGE. THE FOREGOING LIMITATION OF LIABILITY AND EXCLUSION OF CERTAIN DAMAGES SHALL APPLY REGARDLESS OF THE SUCCESS OR EFFECTIVENESS OF OTHER REMEDIES.

#### INDEMNIFICATION

You will defend at your own expense any action against Viewpoint brought by a third party to the extent that the action (including, but not limited, to any governmental investigations, complaints, and actions) relates to (a) any User Content uploaded by you into the App or (b) your use of the App in breach of these Terms or applicable law. You will indemnify Viewpoint for any damages, attorneys' fees, and costs finally awarded against Viewpoint resulting from such action.

#### EXPORT COMPLIANCE

You may not use or otherwise export or re-export the App except as authorized by United States law and the laws of the jurisdiction in which the App was obtained. In particular, but without limitation, the App may not be exported or re-exported (a) into any U.S. embargoed countries or (b) to anyone on the U.S. Treasury Department's list of Specially Designated Nationals or the U.S. Department of Commerce Denied Person's List or Entity List. By using the App, you represent and warrant that you are not located in any such country or on any such list. You also agree that you will not use the App for any purposes prohibited by applicable law, including, without limitation, the development, design, manufacture, or production of nuclear, missiles, or chemical, or biological weapons.

#### GENERAL

Any claim relating to the App or these Terms is governed by the laws of the state of Oregon without regard to conflicts of laws principles. You agree to submit to the exclusive jurisdiction of the state and federal courts located in Multnomah County, Oregon, for the resolution of any and all disputes arising out of or relating to your use of the App. You agree that no joint venture, partnership, employment, or agency relationship exists between you and Viewpoint as a result of these Terms or your use of the App. If any provision herein is found void or unenforceable, it will be severed to the extent void or unenforceable and the remaining provisions will continue in full force and effect. If Viewpoint fails to act with respect to your breach or default of any of these Terms, Viewpoint is not waiving its right to act with respect to any subsequent or similar breach or default. You may not assign, delegate, or transfer your rights or obligations under these Terms. Viewpoint may assign its rights under these Terms without your consent. Unless otherwise specified in these Terms or agreed by you and Viewpoint in writing, these Terms constitute the entire agreement between you and Viewpoint with respect to the App. Any rights not expressly granted in these Terms are reserved by Viewpoint.
